PLEDGE OF ALLEGIANCE

PRESIDENT'S ANNOUNCEMENT

The New Jersey Open Public Meetings Law was enacted to ensure the right of the public to have advance notice of, and to attend the meetings of, public bodies at which any business affecting their interests is discussed and acted upon. In accordance with the provisions of this Act, the East Brunswick Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted at the Board of Education offices, located at 760 Route 18, East Brunswick, New Jersey. Written notice was also provided to the Sentinel, The Newark Star Ledger, The Home News Tribune, The Alternative Press of East Brunswick, and the Municipal Clerk of East Brunswick.

All Board of Education meetings, with the exception of executive session discussions, are videotaped for later broadcast. It is the policy of the Board of Education that video taped meetings are not edited for any purpose. Individuals who speak at the Board's public meetings should be aware of these videotaping rules.

FOR THE GOOD OF THE CAUSE FOR THE PUBLIC

Public Comment Rules

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest. To protect the privacy of all students and staff, concerns regarding individual students and staff members should generally be addressed by first meeting with the appropriate administrative staff.

In order to permit the fair and orderly expression of such comment, the Board shall provide a period for public comment at every meeting of the Board.

Public participation shall be permitted only as indicated on the order of business in Board Bylaw No. 0164.

Public participation shall be extended to residents of this district, persons having a legitimate interest in the actions of this Board, persons representing groups in the community or school district, representatives of firms eligible to bid on materials or services solicited by the Board, and employees and pupils of this district, except when the issue addressed by the participant is subject to remediation by an alternate method provided for in policies or contracts of the Board.

Public participation is not an opportunity to engage in a dialogue with the Board and shall be governed by the following rules:

- 1. A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, place of residence, and group affiliation, if appropriate;
- 2. A participant is limited to three (3) minutes' duration; elapsed time will be determined through the use of a timing device operated by the Board Secretary;
- 3. No participant may speak more than once and there shall be no yielding of time among speakers;
- 4. All statements shall be directed to the presiding officer; no participant may address or question Board members individually;
- 5. There shall be no cross dialogue between the participant and the Board and/or Administration;

6. Upon conclusion of a participant's remarks, the presiding officer will acknowledge the individual's remarks and may respond and/or direct a member of the Administration to respond to an inquiry following the participant's remarks or at the conclusion of the public participation session;

The presiding officer may:

- a. Interrupt, warn, or terminate a participant's statement when the statement is too lengthy, abusive, obscene, or irrelevant;
- b. Request any individual to leave the meeting when that person does not observe reasonable decorum;
- Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
- d. Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and
- e. Waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.

The collective bargaining contract(s) discussed are between the Board and: East Brunswick Education Association; East Brunswick Principals and Supervisors Association.
- Pursuant to N.J.S.A. 10:4-12b(7), "any pending or anticipated litigation or contract negotiation other than in subsection b. (4)" of N.J.S.A. 10:4-12 "in which the public body is, or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer." The nature of the matter, described as specifically as possible without undermining the need for confidentiality, is: Legal advice.
- Pursuant to N.J.S.A. 10:4-12b(8), "any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of, promotion or discipline of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting." 2024 to 2029 SHARED SERVICES AGREEMENT BETWEEN THE TOWNSHIP OF EAST BRUNSWICK AND

THE EAST BRUNSWICK BOARD OF EDUCATION

This Shared Services Agreeme	ent ("Agreement") between the Township of
East Brunswick, in the County of Midd	lesex, State of New Jersey (the "Township")
and The East Brunswick Board of Edu	ucation, (the "Board of Education") dated as
of, 2024.	

WHEREAS, the Township and the Board whenever possible seek to work cooperatively to provide services to the citizens of the Township. The school district is seeking the most cost-effective way to fund capital needs and state policy encourages such cooperation; and

WHEREAS, it is the most cost effective and in the best interests of both the Township and Board to implement this Agreement for transaction of benefits to the community.

NOW THEREFORE, IT IS HEREBY AGREED by and between the Township as follows:

1. In order for the Board of Education to take advantage of the Township's favorable financing capital market arrangements via a shared service agreement the Township will provide capital funding for Board approved projects listed in Schedule "A" attached hereto as requested by the East Brunswick Board of Education on April 4, 2024. The proposed improvements will be mutually beneficial to the Township and Board. The Board of Education's Shared Services will permit use of its facilities for recreational programs by the Township as follows:

- A. Use of school facilities to support the Township's year-round recreation programs and summer day camp programs;
- B. Use of school facilities to support Township police department training exercises;
- C. Use of school facilities and school buses to support Township emergency management protocols and emergency shelters.

The uses outlined in this section shall not interfere with the normal use of the school facilities by the Board. A schedule for such uses shall be provided by the Township.

- 2. <u>Authorization</u>. The Township and the Board of Education shall pass resolutions approving a "Shared Service Agreement" whereby the Board of Education will repay the Township the financed sum over five (5) years in accordance with Schedule "B" annexed hereto and pay all interest on the outstanding notes and costs.
- 3. <u>Initial Payment</u>. The East Brunswick Board of Education will provide the first payment on July 15, 2025.
- 4. <u>Use of Funds</u>. The Board of Education acknowledges that any funds provided by the Township hereunder are to be used for purposes permitted under this Agreement and comply with the applicable provision of the Local Bond Law. Should any of the Township funds be utilized for any other purposes, then the Board of Education shall be required to return the full amount for outstanding bond anticipation note. The funds shall be made available to the Board of Education immediately after the "Note" issued has closed.

- 5. <u>Term</u>. The term of this Agreement shall commence on April 4, 2024 and end on August 31, 2029, unless terminated in writing by both the Township and Board of Education.
- 6. <u>Indemnification</u>; <u>Hold Harmless</u>. The Board of Education shall to the extent permitted by law indemnify, defend and hold harmless the Township, its officers, directors, employees, agents, or servants from (1) any and all claims arising from the conduct, negligence or otherwise act or omission of the Board of Education, its employees, agents or servants; (2) any and all claims arising from the proposed improvements and acquisitions set forth in schedule "A"; and (3) all costs, expenses, attorney fees and liabilities incurred on or in connection with any such claim or action or proceeding brought herein.
- 7. <u>Compliance with Laws and Regulations</u>. The Board of Education shall, at its sole cost and expense, comply with all requirements of County, State and Federal rules and regulations and statutes now in force.
- 8. <u>Bond Authorization</u>. The Township will approve a Bond Authorization to permit bonds or notes of \$6,100,000 to be issued for use by the Board of Education. The Board will provide the required five percent (5%) down payment of \$305,000, which amount can be refunded if the note proceeds are not made available to the Board of Education. The Bond Ordinance shall include an amount of \$6,100,000 with bond or notes of \$5,795,000.
- 9. <u>Governing Law</u>. This Agreement shall be governed by and interpreted in accordance with the laws of the State of New Jersey.
- 10. <u>Validity of Agreement</u>. The terms, conditions, covenants and provisions of this agreement shall be deemed to be severable. If any clause or provision herein contained shall be adjudged to be invalid or unenforceable by a court

of competent jurisdiction or by operation of any applicable law, it shall not affect the validity of any other clause or provision herein, but such other clauses or provisions shall remain in full force and effect.

11. Entire Contract. This Agreement contains the entire Shared Services contract between the parties. No representatives, agent or employee of any Party has been authorized to make any representations or promises with reference to the within letting or to vary, alter of modify the terms hereof. No additions, changes or modifications, renewals or extensions hereof, shall be binding unless reduced to writing and signed by all parties as set forth in Section 13 herein.

12. Amendments. This Agreement may be amended at any time by mutual agreement of the parties, provided that before any amendment shall be operative or valid it shall have been reduced to writing and signed by all parties. This Agreement may not be modified unless the same has been approved by the East Brunswick Township Council and by the Board of Education.
