PRESIDENT'S ANNOUNCEMENT

SUPERINTENDENT'S REPORT

"Good evening, everyone,

The artwork on display in the Board Room this evening was created by students from Chittick Elementary School. The art teachers of these talented students are Felix Martinez and Alexa Csizmar. Tatianna McBride is the Principal.

On Wednesday, February 5th, George Scott presented at the Parent University session on *Raising Healthy Children*. As a family therapist, former Middlesex County Director of Student Services, and current state-wide Coordinator for the Traumatic Loss Coalition, Mr. Scott shared insights on how toxic experiences can impact children's academic success, relationships, and emotional well-being.

He emphasized the vital role parents play in fostering their children's well-being from infancy through high school. Presentation slides are available on the homepage of our district website.

The Social Studies classes at Hammarskjold participated in a special activity entitled A Typical Ghanaian School Day: Know the Past, Shape the Future.

Students participated in a real-time webinar with instructors in Ghana where they were able to learn about a typical day for a Ghanaian student. Students communicated with the instructor via a chat where they asked specific questions based on what they learned in the presentation.

At Memorial Elementary School, Christian Semple's third grade class celebrated the conclusion of their Nonfiction Reading Unit by participating in a small group living wax museum project.

Utilizing what they learned about Nonfiction texts, students researched facts about one famous person in history (past or present) that they would like to learn more about. To add to their presentation, students were given the option to dress like the individual they chose and bring in props as well.

On January 31st, students shared their speeches and slides featuring a video and photos of the individual they chose. The students were poised, engaging and let their personalities shine!

1. Learning Across the District - Warnsdorfer Elementary School

Let Grow is a nonprofit organization that promotes childhood independence. The organization's mission is to help children develop the skills they need to be confident, happy, and capable adults. The program equips parents and teachers with activities and discussion points aimed at encouraging independence and self-reliance in children.

At Warnsdorfer, each month has a theme that they discuss during a class meeting. Children and parents receive a list of suggested activities to gain independence and resilience. The students have to complete an activity by the end of the month and complete a reflection sheet about how they grew and what they learned. They then get a leaf to decorate to hang on the month's branch displayed on our hallway bulletin board. Students have completed a variety of activities including running a mile alone to prepare for the Pacer Test, learning how to ride a bike from peers, and even crocheting a Rainbow Unicorn Plush Toy from scratch!

Public Comment Rules

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest. To protect the privacy of all students and staff, concerns regarding individual students and staff members should generally be addressed by first meeting with the appropriate administrative staff.

In order to permit the fair and orderly expression of such comment, the Board shall provide a period for public comment at every meeting of the Board.

Public participation shall be permitted only as indicated on the order of business in Board Bylaw No. 0164.

Public participation shall be extended to residents of this district, persons having a legitimate interest in the actions of this Board, persons representing groups in the community or school district, representatives of firms eligible to bid on materials or services solicited by the Board, and employees and pupils of this district, except when the issue addressed by the participant is subject to remediation by an alternate method provided for in policies or contracts of the Board.

Public participation is not an opportunity to engage in a dialogue with the Board and shall be governed by the following rules:

- 1. A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, place of residence, and group affiliation, if appropriate;
- 2. A participant is limited to three (3) minutes' duration; elapsed time will be determined through the use of a timing device operated by the Board Secretary;
- 3. No participant may speak more than once and there shall be no yielding of time among speakers;
- 4. All statements shall be directed to the presiding officer; no participant may address or question Board members individually;
- 5. There shall be no cross dialogue between the participant and the Board and/or Administration;
- 6. Upon conclusion of a participant's remarks, the presiding officer will acknowledge the individual's remarks and may respond and/or direct a member of the Administration to respond to an inquiry following the participant's remarks or at the conclusion of the public participation session;

The presiding officer may:

- a. Interrupt, warn, or terminate a participant's statement when the statement is too lengthy, abusive, obscene, or irrelevant;
- b. Request any individual to leave the meeting when that person does not observe reasonable decorum;
- c. Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
- d. Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and
- e. Waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.

4. Emergency Contract Report Pursuant to N.J.S.A. 18A:18A-7

Pursuant to N.J.S.A. 18A:18A-7, any contract may be negotiated or awarded by a Board of Education without public advertising for bids and notwithstanding that the contract price will exceed the bid threshold when an emergency affecting the health or safety of occupants of school property requires the immediate delivery of goods or the performance of services, provided that the contracts are awarded in a specific manner.

On Tuesday, January 21, 2025, there were heating system failures at Central Elementary School. Specifically, one boiler experienced a ignition/flame failure and one of multiple boiler chambers cracked causing water to be expelled from the boiler. The remaining operational boiler is insufficient to maintain temperature within the normal range in the building.

Manhattan Welding Company, Hillside, NJ, the district's boiler repair and maintenance vendor, was called in to initiate emergency trouble shooting and subsequent repair for a contract total of \$96,500.00.

CURRICULUM AND INSTRUCTION

1. Contract - Bailey Eng

The budget for the Arts Education program includes funds to continue the district commitment to aesthetic education by bringing performances and workshops to the schools.

This Artist in Residence, Bailey Eng, will work with the Pit Orchestra Director and musicians to accompany the rehearsals and performances of this year's EBHS Musical Production: *Mama Mia*, as a Pit Musician. <u>COMMITTEE REPORTS, INFORMATION ITEMS AND FOR THE GOOD OF THE</u> <u>CAUSE FOR THE BOARD</u>

1. Finance Committee of the Whole - FY2026 Budget Discussion (transcribed from the board meeting video)

MR. GIULIANA: I wanted to begin with a little bit of information that was published yesterday. And in case members of the Board or the community hadn't seen this headline, "New Jersey faces \$3 billion budget hole and Trumps Federal cuts could make things worse." And just one part of one sentence in the introductory paragraph, "New Jersey is currently starting down a more than \$3 billion structural deficit, as Governor Phil Murphy prepares to unveil his next and final State Budget Proposal this month." That proposal is slated for the end of the month. I believe it's February 25th.

The interesting thing, I think, and sadly, regarding a headline like this is, it's kind of the preparation for what we might expect in terms of State Aid. As we've been talking about not knowing what State Aid may be, this headline does not bode well. So, I thought that's an important thing to note.

I wanted to share a communication that we received from the Department of Education, and I'll briefly go over what this communication is about. One of the revenue sources that the district and all districts have in their General Fund Budget, is SEMI Reimbursement Revenue. SEMI is the "Special Education Medicaid Initiative." And we have done a lot of work, we do a lot of work annually through the child study teams administratively in trying to maximize the amount that we receive back from the State and ultimately from the Federal government. We do all the work, we get the least amount of share of money, and that holds true for every school district. To give you a little bit of an example, we generated in Fiscal 2023, \$176,000 in revenue, that was a small portion in comparison to what the State gets to keep, versus what the Federal government keeps. In Fiscal year 2024 we generated \$122,000 in revenue and in

Fiscal year 2025, because of the additional efforts that we had identified necessary to increase that revenue stream, we have budgeted \$331,000 in revenue. As a result of an analysis that was done at the Federal level, the Federal government is reducing the amount of payment for various services provided. So, that ultimately reduces what we would be able to budget for revenue.

The State just opened up the budget system for us for next year's budget, and they populate what that budget amount is for revenue. That number for Fiscal Year 2026 is \$38,000. That's nearly a \$300,000 reduction from what we've budgeted in the current year for an estimated revenue amount.

You'll see on page 3 of the document I distributed, this is a memorandum that came from the Department of Education, and there has been a lot of activity, a lot of communication happening the last couple of days regarding the impact this has on school districts. But on page three, you see what the rates are for paying for various services, and you'll see in the first section to the left what are the previous payment structure, and you can see what the share is, the Federal share, the Federal gets 50% of the share, the State gets 32.5% of the share of funds, and the district share is 17.5%. But when you look at those amounts in the previous section versus the new amounts, they're drastically less. More information to come on this, but I think from a high level, it's important to note that this is a revenue area that will not bode well as we're developing this budget. So, just as a point of reference in terms of how many Medicaid eligible students we have, out of approximately 1,400 special education students, 347 are Medicaid eligible. I said earlier that we do all of the work for the least amount of money and that is true, because the school districts must do a lot of the work related to validating the services that are being provided in order to submit for reimbursement of Medicaid eligible costs, and that amount is going to be substantially less. I would guess that the effort involved will cost more than the revenue generated for this next year.

It's not optional for us. If you look at the first page of that memorandum, the third paragraph under New Jersey Administrative Code, "failure to maximize Special Education Medicaid Initiative requires districts with more than 40 SEMI eligible to participate." I mentioned that we have 347 Medicaid eligible students right now, so we don't have a choice, we must participate. The consequence of failure to participate is a required corrective action plan, and if I remember correctly, also impacts our QSAC scoring.

DR. VALESKI: It does. I just wanted to reinforce, Mr. Giuliana, what you just said, but this is one of those areas that we're learning about real time, right now, sharing with the community just as we learn it, and it's a situation where it's going to at least ballparking it, it could end up being a cost to the district, not a revenue to the district. So, we just wanted to let you know.

MR. GIULIANA: Okay, handing out another document here. One of the items that we've discussed is the potential for increasing the fees charged for clubs, activities and athletic registrations. So, I'll just walk you through this document. So, this is looking at, conducts, it is an analysis of what our participation is in terms of registrations for each of the various activities for the various seasons, including

athletics. The columns are pretty self explanatory. The grey columns reflect the value of free and reduced registrations. Now, children who qualify for free and reduced lunch do not pay, but this information is more to give you a reference point as to what that value is, if there were to be payment from those groups. When we move across this worksheet, when we get into columns I through N, this is providing the calculations for what if the fee for a club were to increase to \$20, and the fee for athletics to \$75. K goes from \$25 to \$100, and then M \$30 and \$125. You'll see in the bottoms of columns I, K, and M what that estimated increase in revenue would be. So, by increasing the club price to \$20 and athletic price to \$75, the increase in revenue is approximately \$63,690. By increasing the club price to \$25 and the athletics to \$100, the increased revenue is \$127,380. And increasing clubs to \$30 and athletics to \$125 would result in approximately a \$191,000 increase in revenue.

HEATHER GUAS: Can I ask, how long have we had, I mean it's been this way since I've been paying it, but how long have we had the \$50 registration fee for athletics and \$10 for clubs?

MR. GIULIANA: I think it's been about 15 years it has not changed.

DR. VALESKI: It was that way when I came to East Brunswick.

LOUIS FIGUEROA: I have also a question Mr. Giuliani, um Mr. Giuliana. The families, for more than one kid, is there something that we've normally done in the past for families that might have multiple children, something that we've done to ease the burden a little bit on payment? Even at the \$50 level?

MR. GIULIANA: Uh, I, right off the top of my head, I don't believe there is. I think it's a \$50 per student per sport.

LOUIS FIGUEROA: So that would be something that possibly we can incorporate into any increases.

MR. GIULIANA: We should take a look at that. We have to analyze what that impact would be. Yes.

DR. VALESKI: Mr. Guiliana you're going to ask for these back, right?

MR. GIULIANA: Yes.

DR. VALESKI: So, any notes on these, I want to caution the board members if they're writing notes on these, we're going to ask for these documents back.

MR. GIULIANA: Yes, we're not ready for, this is for discussion purposes at this point, and this is on the next document I'm going to hand out as well, we can have discussions on these but we'll need to recollect them. So, let's see.

HEATHER GUAS: Can I explain a little bit?

MR. GIULIANA: Yes, please.

HEATHER GUAS: Okay, I just want to explain, because the way we're doing it is different this year than in years past. This is the first year that the Finance Committee has been a committee of the whole. So, in the past the Finance Committee would meet with four Board Members and Administrators, and then there would be a second meeting with the entire Board. This year we've moved it to a Committee of the Whole, which means we're doing it from the very first step in public and everyone working together in hopes that there's not just more transparency, but the communication is more even and level across the Board, but we're sorry there's still some of the documents are still confidential.

MR. GIULIANA: So, on page one, and if you flip through the entire document, you will note that the last two pages, that would be 11 and 12, are not included in the packet because on the advice of Council, though, because the positions that we'd be talking about are so specific that we really can't have that discussion in a public setting. However, through the page one summary of each of the areas and we are covering adjustments to the elementary school hours in terms of how late the schools would be opened after 6:15. In other words, right now we are open later, we have access to the buildings later, this first recommendation is that the buildings at the elementary level would close at 6:15. What that means is that, while typically there would be requests for use for meetings, could be the scouts it could be PTA's and so forth, we would provide access to one of the three upper schools to have meetings at those facilities because they would remain open later. If there was an event that needed to occur at the elementary level, within the home school, in that case there would have to be a fee, to be able to pay for the necessary security coverage to keep the building open. To make that change, that results in approximately \$335,000 savings. It doesn't reduce staff, it is simply closing the buildings at 6:15, and that is an item for consideration.

The next item on this list is summarized as Grades 5 to 6 enrollment. That is our staffing patterns in our schools are driven by enrollment and because of the change in the 5/6 enrollment projected for next year, there is a slight decline in that. So we would automatically be able to reduce four positions, four teaching positions at Hammarskjold as a result. And we typically do this automatically at the elementary level, the budget already reflects that at the elementary K-4 level, and this is an area where we can make a reduction simply because the numbers are decreased for next year. This particular segment is worth approximately \$382,000.

The next item is on Special Education, and this is not to reduce services, this is related to, as I mentioned for the grades 5/6 segment, related to the movement of our Special Ed enrollments and who requires services and who would not for the next year, and based on the projections from the Special Education Department, the reduction overall in this area is approximately \$425-430,000.

DR. VALESKI: And I just want to reinforce that is in consultation with the Director of Special Education.

MR. GIULIANA: I think it's important to note also that any of the items that are being put forth, we had tasked the entire Administration to collaborate and identify areas that

were feasible to be able to reduce, so these are recommendations that have come up through the administration. They were, there were groups of Principals, and Supervisors and Department Heads, and so forth, that worked collaboratively in identifying each of the various reductions that are being discussed at this point.

The next item is highlighted as stipends and if you go to page five, just quickly go through this. The first two items relate to the Summer ESL Program. We are looking to reinstitute the Summer ESL Program for this coming year, this would eliminate this program for the summer of 2025. That amount combined, and these are stipends paid to staff to run these programs, and Dr. Boley, I believe this is a five or six week program? Yeah. So, that is approximately \$155-156,000. And then a recommendation from the High School is the removal of Saturday detentions and re-evaluating the Code of Conduct to determine what would be a better way to address discipline as opposed to having Saturday detentions, which if I recall correctly Dr. Valeski, was not being found to be effective.

DR. VALESKI: No, it's not effective.

MR. GIULIANA: That reduction is \$2,800.

DR. VALESKI: I don't even know how to explain it anymore, it's not, it's not effective.

MR. GIULIANA: So, the total related to those areas is approximately \$158,568.

The next is categorized as non-personnel. And I think that if we go to page six, I'm going to go through the rows 5 through 8 to begin with because those are not emotional in any way. Elimination of student Agenda's purchases, elimination of a Naviance program for Hammarskjold, not Naviance overall, just Hammarskjold. A Naviance access at Churchill, and a Canvas training portal. Based on the recommendations that have come up from Administrators, those four areas would be eliminated. The one item on row four, is the elimination of the Fairview Trip. Right now, we are running the Fairview Trip not as we had previously, but the Fairview Trip on its own is \$101,500 and that would need to be a consideration for the Board.

DR. VALESKI: And also in discussion, is parent advocacy to investigate fundraising for Fairview. So, I want to put that on the table too, so that discussion is on-going, because certainly there have been, and I understand the value of students going to Fairview and having that experience, but the overnight experience versus the day out and day back experience is much more expensive and almost impossible to supervise at this point and time.

MR. GIULIANA: The next category is Elementary Specials. This would involve the realignment of teaching assignments and restructuring of the elementary schedules, and this would result in a reduction of four full-time positions and three part-time positions. Net impact on this area is just over \$500,000.

The next category is Secondary teaching. There are a variety of items within this segment, and I'll quickly go through what the topics are. A position reduction, not replacing a retiring teacher which would require the institution of six period teaching

assignments, but that is one of the items that's on the list. Eliminating the co-teaching model in honors music. Double late-in and early-out option for eligible 12th grade Seniors. Eliminating 6th period Electives. Sixth period for elective classes in core content areas, which would be ELA, Math, Science, History, and that would be unless it's absolutely needed in order to optimize the scheduling. Eliminating Spanish electives, and looking for ways to optimize the General Ed study skills. In total these groupings are in excess of \$300,000.

The next item is in athletics. The recommendation that has come up is for 9th grade Athletic program to be eliminated. The 9th grade athletic program has the least amount of competition with other schools. 9th graders would be able to try out for the JV or varsity teams so there are opportunities for those students. Overall the savings in this area would be just over 140,000. Important to note that this is NOT the elimination of Middle School Sports. It does not eliminate Middle School Sports.

Transportation. First item on the list is with regard to Graduation and not providing buses, where parents and students would be responsible for transport to and from the graduation venue. Churchill late buses are on this list. The elimination of late buses. Late buses, and you'll hear that in a couple of other instances, late buses are offered as a courtesy, they are not mandated by the State. Late buses at the High School. Athletic shuttle between Churchill and the High School. Now I'll say that that's probably going to need to come off the list in order to enable 9th graders to be able to participate in the High School athletics program. The Hammarskjold late runs as well. The last item is a significant impact but it is on the table for discussion, and that is reducing the hours for full-time bus drivers from 8-hours a day to 7-hours a day. The total impact for these areas is over \$818,000.

Just generally speaking, there are those couple of areas that I can't get into the details because the positions are easily identified to individuals, but the additional savings as a result of those, and we would discuss those in another venue, but the additional savings resulting from those is over \$760,000.

So, in total with all of these items, these come out to \$3,959,919. That's still short from the numbers that we had talked about and just as a reminder when we discussed the range, I just want to pull up my worksheet from the last Board meeting, but the range was between \$5.8 and \$7.8 million. So just on the low end and that's presuming that State aid remains unchanged, just from the low end we are still roughly \$3.9 million short.

LOUIS FIGUEROA: Mr. Giuliana if I may, will the Board be privy to the suggested or recommended cuts that the Administration made? I think you mentioned the Supervisors and Principals had made suggestions, recommendations about potential possible cuts?

MR. GIULIANA: They were all included in here.

LOUIS FIGUEROA: That's, so they all...

MR. GIULIANA: All of their recommendations are all incorporated in here.

LOUIS FIGUEROA: Right, thank you.

MR. GIULIANA: Most of what you see here came through the Administrative process.

DR. VALESKI: Yeah, the collaboration.

MR. GIACOBBE: Dr. Figueroa, just to note though, there were, there are two last pages that I recommended, Page 11 of 12 and 12 of 12 to note be in because they're more specific, you guys would have to RICE the potentially affected employees and discuss that in closed session.

LOUIS FIGUEROA: Okay, that's what I'm looking for.

MR. GIACOBBE: This is just, but it gives you an idea of the area.

LOUIS FIGUEROA: Thank you.

DR. VALESKI: Mr. Giuliana can you restate for the public, how much bank cap is already included in this calculation.

MR. GIULIANA: Yes, so we have currently, that shortfall already takes in the consideration maximizing our tax levy, the 2% cap, which is statutory and we have approximately \$1 million in banked cap, so those two amounts are already incorporated into the bottom line. So even with the increase in tax levy, we still have that shortfall. And just as a reminder, you know the tax levy doesn't cover salary and benefits, the increase in salary and benefits. There are, without adding positions, I think there were two positions reflected in the budget that were requested from the Special Ed Department, but our increase in salaries and benefits right now, without taking any of these reductions into consideration, is over \$6.9 million. The tax levy and the banks cap is \$3.9 million. So, there's a gap right there, with doing nothing.

DR. VALESKI: So, this is a work in process. We are, we will continue to work. We have made progress, but we still have a ways to go, and it's getting tougher as we go. So, but we wanted to update the Board with where we are at this point and time. We committed to doing that, being transparent with that. But as Mr. Giuliana said, in our conversation with legislators, our conversations with anybody at the State level, we're not getting any hope that we are going to see anything other, at the best-case scenario, flat funding from last year. But we are fearful that that funding will be reduced, we just don't know yet and we won't know until the last minute.

MR. GIULIANA: Without getting into details, but providing a high-level piece of information here, questions concerning Bowne-Munro, and there's no, we're still analyzing. I'm sorry I think I gave one too many out. So, what are the, what's the impact of Bowne-Munro if Bowne-Munro were to be repurposed. I don't want to say closed, but repurposed, and when I say repurposed, we've discussed the potential of reutilizing the facility to expand the ELA program. That's the Early Learning Academy.

DR. VALESKI: Which is a revenue generator.

MR. GIULIANA: It is a revenue generator. So, based on the rough estimates of opening additional ELA classes at that facility, that would generate Net income of roughly \$577-578,000 and that is only based on the waiting list that we currently have. Strictly the waiting list. If that, if we were to be able to maximize every seat that is available throughout the district, then that has the potential to go up to \$878,000. Now from those amounts, we have to also Net out of that the cost associated with having a nurse, which would be paid out of that program, having a custodian for the facility and having security. Those costs would be paid out of that program. So, on the very conservative side, it could generate over \$350,000 in revenue, and the savings from certain key positions from the building, this is not everything, but certain key positions, is an additional \$760,000. So in total, this is about a \$1.1 million impact to the good for the bottom line of the budget.

DR. VALESKI: And just to restate the numbers Mr. Giuliana stated about the totals did not include this analysis. Correct?

MR. GIULIANA: That is correct, this was not in the other summary that I provided.

DR. VALESKI: This is in addition to and still in deliberation.

TIMOTHY CUMMINGS: That's at max capacity?

MR. GIULIANA: No, that is not. That is not at max. There's room for that to be more, but I think without having even the initial experience of opening that up, I think it would be ill advised to try to budget for the maximum revenue and not knowing what that would be. I think it's comfortable knowing that we have a waiting list and we can accommodate that waiting list and generate \$350,000 in net revenue to go to support the General Fund budget, that that would be the thing to do.

TIMOTHY CUMMINGS: If that were the case, then that would mean that ELA at every other school would not exist.

MR. GIULIANA: No, currently would remain.

TIMOTHY CUMMINGS: It would remain.

MR. GIULIANA: This is in addition to.

TIMOTHY CUMMINGS: Thank you.

DR. VALESKI: I want to say publicly too, because I know the concern about providing an option about closing Bowne-Munro, or repurposing Bowne-Munro, is what will happen to the students, what will happen to the teachers, and we're looking at those options right now because we want to make sure that we keep, to the greatest extent possible, those students together if we can, that's an option we were hoping to look at. It's not our intention to spread children throughout the district. I'm not saying that's not what might happen, that's not our intention. And so I wanted to be clear about our objective in looking at this and what we're trying to achieve. We don't have those answers yet, but that's what we're working toward.

WILBUR PAN: Quick question: the last sentence where it says if every available ELA seat through the district is filled, what's the probability of success in terms of hitting that mark? Do we think we're going to be able to hit it, or is it...

MR. GIULIANA: I can't give you a statistical probability on that at this point...

WILBUR PAN: Oh, ballpark.

MR. GIULIANA: This is, I'm not going to do that, because I'll be held to it, and I'm not going to do that. I don't think we could even be able to guess that number until we get, until we were able to do phase one, and phase one would be open up the additional opportunity for the waiting list, and then see what else we can garner, once the space is available. Because the word gets out, if folks know that we don't have space, they may not even be applying.

WILBUR PAN: Mmm-hmm, okay.

DR. VALESKI: Another option too, Mr. Pan, is that you know, our community members may decide that they don't want to go to Bowne, it's not their home school. So, they want the ELA program in their home school. So, they might choose not to fill a seat based on that decision. So...

WILBUR PAN: Okay, thanks.

HEATHER GUAS: I wanted ELA in my home school and when it moved to Hammarskjold I still went to Hammarskjold. Good program. Could you explain, because someone had said during the Good of the Cause, that the idea of repurposing Bowne, closing Bowne would just be firing all of the Bowne-Munro teachers. Could you explain, I know we discussed this also yesterday that that's not actually, I, I am uncomfortable with the idea of firing or reducing jobs of any teachers.

DR. VALESKI: Correct, and I don't want to give specifics, but that's not our intention with the purpose of repurposing Bowne. That's not the intention, but I'm just hesitant to give a public statement that might not be accurate in a week or two. I'm not trying to scare anybody, I just don't want to give that information in public because it could be utilized...

MR. GIULIANA: We don't know what it'll be yet...

DR. VALESKI: Yes.

MR. GIULIANA: And, but the numbers that I just went through regarding Bowne-Munro are exclusive of the K-4 teaching staff. So that does not include teaching positions, so just so that we understand that.

DR. VALESKI: That doesn't include the reduction...

MR. GIULIANA: It doesn't include the reduction of K-4 teaching staff, right.

LIWU HONG: So, if Bowne is repurposed, what kind of impact will have to the class size?

DR. VALESKI: We don't have that analysis complete yet Mr. Hong.

LIWU HONG: Okay.

DR. VALESKI: So, we wanted to share with the Board that we had begun the analysis, that this was not something that, because we have been challenged by members of the community that we haven't thought through this, we have. But we wanted to share to the point that we can, what we've done so far. And I want to make sure that everyone understands that the Board has made no decision about any of this.

MR. GIULIANA: And I think it's important, just as a reminder, that that information will be driven by the redistricting study that's underway, to give us the data related to numbers of students at each location, what that might look like for each of the elementary schools, and also keeping in mind that there are, at a number of our schools, classrooms that are currently not occupied. So, that would, we expect, would be able to assist in taking on the additional students that would be redistricted out of Bowne.

ANNA BRAUN: When do you expect that data to be available? About the redistricting?

MR. GIULIANA: I will ask to see what their timeline is, but we will not have that before, certainly not before adopting a tentative budget.

ANNA BRAUN: Okay.

MR. GIULIANA: That is for certain. I can share with you that I have been in contact with them today, providing them supplemental information regarding our building utilization for the elementary schools. So, they're analyzing that. They want to do site visits, so I'm waiting to hear from them as far as when that might be scheduled, but it is a work in progress.

LAURIE HERRICK I have a, just want to address some other community member concerns. We hear that we should have planned for this or that we knew it was eventually coming. So, my understanding as for a school budget, is that when you are provided with funding and money for that budget year, your job is to spend that money, right? There's not a large percentage that can be carried over, which is why we see district's who get a large sum of money, right, also say, there's no way that we can spend this. Like, I think one school, one district got a lot of money that they were not expecting this year, and said, there's, we love the money, but there's, how do we even begin to look at programs that are sustainable after a year if our funding changes. So, there's not a lot of money, right? That we can carry over. The point of the yearly budget, is to spend down, the yearly budget, right?

MR. GIULIANA: So, yes. So, a couple of points. First, as a school district, and that is

any school district within the State, the maximum that we can maintain in our fund balance, which is the, it's the "emergency reserve" right? When everything else fails, you know it's that glass box on the wall that you break open, and we don't have the latitude to simply go utilize that money, but the maximum that we can maintain, is 2% of our general fund. That's the maximum. We can't fall below that without permission from the State. So, I would never recommend that we go to that and try to utilize that money because if things really were to go, some, some catastrophe during the course of a year happens, we would need that resource.

TIMOTHY CUMMINGS: What does that equate to?

MR. GIULIANA: Well, 2%, our General Fund if we're looking at our General Fund Budget, it's almost, it's a little over \$4 Million, yeah a little under \$4 million. Because if we're looking at about a \$200 million budget now, 2% of that,

MG: \$194.

MR. GIULIANA: So, my train of thought now, so that's the 2% side, and now I lost the rest of my train of thought. No, no don't try to help me. I'll come back to it, but it was, but that 2% issue is a big issue.

DR. VALESKI: Mrs. Herrick, just ask your question again, maybe it'll refresh his memory.

LAURIE HERRICK My question is, does, you know, there's obviously a community concern, you knew, like we knew it was coming, why don't you plan. But the thing is that we're not allowed to hold that money, right? We're given a yearly budget by the State, by our Federal means, by the revenue that we bring in. We have to spend a certain amount of that, we can't just say, oh we expect to get a cut next year, let's put it in the bank and it can sit there until next year when we're cut. That's not a possibility.

MR. GIULIANA: It's not a possibility. We don't have, oh, the other portion, that, this is what I was going to talk about. So, we already generate a certain amount of revenue from unexpended funds. We know we're not going to, or we hope, we're not going to spend every last dollar in the budget. There has to be something remaining. If we're spending every last dollar, then that's a problem because then there's no buffer. So, how do we not spend that every last dollar? Well you know, we work on our contracts for services, we hope for improved health benefit experiences, perhaps our workers comp costs are not as high as budgeted.

So, there are a variety of things. Uh, breakage, employees who retire during the course of the year, and their replacements come in at a lower salary amount. Folks that switch health plans from maybe a family plan to a lesser plan because of changes in circumstances. On the other side, we have those that go the other way, where they may have a single or a employee and partner plan and have grown a family and now the other side of that coin flips. But we generate a certain amount of revenue each year, or unspent money that goes to support the subsequent year's Budget. We've been pretty consistent with what that is.

The danger in overestimating that amount for a subsequent year, is that one, if you don't generate that money when you close out the year, you already have a structural deficit in the subsequent year. Second, that might work for one year, but then what do you do with second subsequent year after that? Or the third? Because once, if we're, if we're, and let's give, use a hypothetical: if we're budgeting Fund balance of \$5 million, and we say, you know what? We've got to close the gap, let's make it \$7 million, so we add in another \$2 million. First, you have to be able to generate that additional \$2 million out of the current budget to be able to do that, but then you've set up the budget to have to do that in every subsequent year. Is that even possible? And chances are absolutely not. That just really aggravates the structural deficit that would be encountered down the road. So, we don't have a piggy bank that we can put the money into.

DR. VALESKI: Mrs. Herrick, I'm sorry I just wanted to tell you, one of the things we did after last year's budget, was when we had a position to organically leave the district, retirement, resignation, we started looking at every position, and whether or not we needed to refill that position. We went through that process all through the year, to make sure that we, if, and that didn't impact anybody because those people had already left. But we went through that process too.

LAURIE HERRICK Yes, thank you. I, and I do this only because I know I was not here for the public portion of last, of our last meeting, and so I know that there are also questions about you know, what have we done. And I wanted to just address that as well. Many Board members up here have attended meetings with legislators, we have advocated on behalf of the kids in our district, as well as the kids in other schools, and other districts because it's happening all around us for cuts.

I did go to Trenton during one of the school funding hearings and actually at our reorg meeting on January 2nd, I provided the dates for the school funding testimony, as well as the date for the written comments, and I said if anybody had any questions they could reach out to Dr. Valeski, and he was more than happy at that time, he said of course.

We went over a few things that I thought were important for people to know, regarding what else we were looking for, regarding our school funding. And it's not just the changing of formula, right? Because a lot of us that have been up here, that for a few months want to know that with meetings through legislators they were not looking at changing the actual school formula this year. A lot of them feel that it works for the majority of Districts, and that maybe there needs to be some overall tweaks. But even last week there were quite a few of us as Board members that were on a call with Senator Gopal, who's also somebody that you know I've spoken to before, I know I'm not the only one. And you know that the new bill that they're looking at, 3917, that does not address the actual school funding formula. It kind of just looks at more Bill transparency, capping losses at 2% of the operating budget, extending the budget calendar, and then eventually they'd like to see all extraordinary Special Education go to the State. Senator Gopal is also wanting to see more consolidation of districts with low enrollment and eventually look at Charter Schools, but I will also say this:

The funding is not something that's just here. I mean, I sat through hours of testimony

and some of the towns that were brought up here, I, I won't repeat it, but I, I've watched people from other school districts talk about how they've gotten rid of late buses, they've had to close schools, they put the tax increase to 9.9% last year when it was allowed. They have cut bands, they have cut out clubs, they have eliminated 250 positions, they've closed, another school has closed in another town. There's a bunch of District's that call themselves The Biggest Losers and that was South Brunswick, Old Bridge, Lenapeak Valley, and Scott Feder talked about how they were the biggest losers and then East Brunswick and other towns were the newest losers. Monroe, our neighbor, they don't even offer full day Kindergarten, they can't get a Grant for preschool, they had a problem with one of their schools, they couldn't pay to have their school fixed, so their Town Council had to give them money because the State wouldn't pay, wouldn't help them pay, they had to replace a boiler. So, their Town Council voted to give the school, the elementary school money to fix it. They just did a High, new High School years ago and it is, it was over capacity the day it opened. So, we have all of these District's around us, and throughout the State, and we do talk to them, you know, as part of New Jersey School Boards, and our Legislative Committee. We talk, we have meetings, we have legislators there.

We're trying to let them know, even Dr. Valeski was on last week with Senator Gopal and so, instead of looking at the big picture of we're not changing the school funding formula this year, what can we break it down for our District. And Dr. Valeski expressed to him our concern with the raising cost of Out-Of-District, and how it could be the middle of the year, and the District could, uh the Out-Of-District School could raise the cost and we have to pay that cost. So, those are barriers to us when setting a budget, because we don't know what, you know, what that raise could be. So, we're trying, we're advocating, and I could go on and on because I know there are so many people on this Board that have tried, over, since our last budget to really take it on. I know, President Guas, you met with some of our, Senator Stanley, and I don't want to talk for anybody else up here, we all share the accolades and we all are trying to work together to fix what we can, but it's like, if it's not money that's there, how are, how are we getting it?

MR. GIULIANA: One of the things that you mentioned was that, that proposed Bill to capping the loss to 4% of the operating budget...

DR. VALESKI: 2%

LAURIE HERRICK 2%

MR. GIULIANA: Oh, 2%. 2% of the operating budget, if we're looking at our budget for next year, it's \$4 million.

LAURIE HERRICK Right.

MR. GIULIANA: We can't afford that kind of a loss. That does nothing for us. That's, that's devastating. Absolutely devastating. So, that's not a help.

LAURIE HERRICK: No, no!

MR. GIULIANA: I'm just, I'm just saying I mean, you know, it may sound like, you know, as a, as a talking point out there, well we're going to cap the loss, but when you look at what our operating budget is, as almost \$200 million, 2% of that is \$4 million. We can't sustain that. We're already dealing with having to close a gap based on a loss of State Aid that's nowhere near that, or flat State Aid.

LAURIE HERRICK: I totally, absolutely agree. And this is not Laurie Herrick saying this...

MR. GIULIANA: Understood...

LAURIE HERRICK: But this is the Senators, the people that I'm talking to say well you're from East Brunswick. And if you want to continue to have the programs that you have and provide the Education that you have, then the residents of your town should be willing to put up that money. And this is not Laurie Herrick...

MR. GIULIANA: But this is, but this is the fallacy...

LAURIE HERRICK: Right...

MR. GIULIANA: Here's the fallacy in, in the statement when legislators say that you should be able to put up the money.

LAURIE HERRICK: Right.

MR. GIULIANA: From where? Because first of all, to what extent to we tax the community, and the ability to do that doesn't really exist!

LAURIE HERRICK: Right.

MR. GIULIANA: When there's a cap.

LAURIE HERRICK: Right, a cap at 2%. Yes.

MR. GIULIANA: So, that's a fallacy.

DR. VALESKI: And this Board, traditionally, has been resistant, not only reluctant, but resistant to raise the burden on the local taxpayers. There have been, there have been situations where we've been below the 2% cap in previous years.

WILBUR PAN: I'd like to piggyback on Laurie's comments about the meeting that we had with Senator Gopal. I was on that meeting too, and in the time, I've been trying to figure out this funding formula thing, and I ran across something that was very surprising to me. And that is in terms of how the State funds Special Education. The way the formula works, is that the State assumes that every District in the State has the same percentage of Special Education students. A number is generated from the total student population and they say, okay well we think you have x number of students, and that's what generates the total amount of the aid. It's a, is calculated on a per student basis. East Brunswick's percentage, in terms of our Special Education

students, is about 4% higher than what the State assumes. So what, and just to put this in numbers, the State assumes that all school Districts has about 14.7% special needs kids, our number, our numbers is around 18, 18.5 to 19% depending on which year you take a look at. So, what that means is that we've been given money for about 300 less special needs kids than we actually have, and that's, and we're expected to use that funding to support the needs of all the students.

I also just want to repeat a thing that Tim had mentioned last meeting, or the meeting before that. In terms of the way that we're spending money on student's, we're in the middle of the pack for the school District's in our area that are like us. North Brunswick, South Brunswick, Edison, Woodbridge, us and Monroe. We're right in the middle in terms of how much we're spending per students. So, I think it's hard to make the argument that the school District has been wasting money, because we're certainly not doing it based on how much we spend per student. And, arguably, we're doing more with the money that we have given the special needs population that we have. And if you look at our outcomes in terms of education, I'm willing to put our outcomes above any of the other school District, seems to be a bit of a bargain. It doesn't help the problem, but I think it helps reframe the problem in terms of what we're actually looking at and what we're trying to do up here. And I think it would be good to keep that, those facts in mind when we're trying to work through this issue.

HEATHER GUAS: The other thing I want to add, and it's such a perfect segue, is that the language from the State right now is not, you know we talk about Excellence. We want excellence in our programs, and we have worked very, very hard to maintain that for years and to build. Excellence is not the language that is coming from the State. The word that is repeated is adequacy, the State is not interested in maintaining our excellence. The State is interested in adequacy, and there was someone today who came up and said you know they're trying to make us into basic schools, it feels like it's trying to be basic schools, and I would say that's accurate. From the State right now, the language seems to imply that they are looking for us to achieve mediocrity...

MR. GIULIANA: That's right.

HEATHER GUAS: ... and that we are basically being punished for doing better than that. The other thing is that we went to the State last year about the discrepancy between our actual percentage of student's in Special Education versus the State's estimate and asked them to look at it again...

DR. VALESKI: We did.

HEATHER GUAS: ... and...

DR. VALESKI: There was no...

MR. GIULIANA: There was no change.

DR. VALESKI: No resolution.

HEATHER GUAS: The State wouldn't consider it.

LIWU HONG: All right, so last meeting one parents question to us, you guys are elected, what did you guys do to get money? So, personally and one big challenge for the Special Needs Student is the cost for Out-of-District placement. Some student's cost almost \$200,000 per student per year, which is very big number. For this kind of cost, the service provider simply just give us the bill. We have no bargain power at all, we have to pay required by law. Let's say they give for \$200,000, they will have to pay \$200,000. If they give us \$250,000, then we'll have to pay. For this topic, I personally talked to Senator Gopal last year twice. I said we must have mechanism there to control this out of control charge. The school District in New Jersey has no bargain power at all. But, I tried multiple times, then nothing going to happen in short term. This is big burden for school District like us. We did very, very good for the Special Needs education, by doing good we got penalized. Because we, just like Magnet, we're attracting people from other place to East Brunswick, which make the situation even worse.

JAIME FALCO: If I can piggyback on that, and please correct me if I'm wrong, we have looked to provide more services in District so that children who were typically placed Out-of-District would come back to us. I believe we've been successful that number has been lowered since last year, but with inflation and no bargaining power, our costs have increased from last year. Is that correct?

DR. VALESKI: That's correct.

JAIME FALCO: Thank you. And as Liwu had stated, with no negotiation power, and the State has a variable reimbursement on these types of numbers, the first \$45,000 of Out-of-District placement come from us, regardless of what the cost is past that, that's always our expense right out of the gate, you know, and children deserve their best opportunity. This is not a District that's going to say No, this is not a District that will turn people away when they need help, and I'm really proud of that, but it is a difficult reality then, when we look at numbers, and we look at the State and how funds are earmarked. We don't have as much ability to spread the money the way I think the public believes we do. There are very specific rules and laws about what funds things can be spent and where and how. And I thank everybody who stayed tonight, I know it's a pretty long meeting and thank you for allowing me to speak.

HEATHER GUAS: Anyone else?

LOUIS FIGUEROA: Thank you, President Guas. I'd like to tell you a good story tonight, if I may. And what I'm going to say can be said for all of our athletic programs at all levels, including our 9th grade programs. Two years ago, an Edison teacher decided that she wanted to be part of the Girl's Basketball program here in East Brunswick. So our Head Coach, Travis Retzlaff decided to make her his Middle School basketball Coach, and this young lady had played, went to school here in East Brunswick, was an all-star guard for the program. She had such a positive experience throughout her whole High School career that she went on to teaching, landed a job in Edison, is raising her family here in East Brunswick, and she wanted to give back to the program that meant to much to her. Her name is Kara Catanho, she was Kara Monteski when

she played at the High School. Under the watchful eye of Head Coach Travis Retzlaff, she took a bunch of young girls and transformed them into a winning team. Undefeated in their first season together, similar record their second season. These girls are now Freshmen and Sophomores, and they're helping the Varsity Team win games. But that's not where the story ends. It's where it begins. These girls are part of something that they could not have attained individually. They're a team. They bleed, sweat, laugh, cry, win and lose together. When you watch them play, you are watching resilient warriors. They're tough, hardworking, focused. They don't have excuses, they don't make them. They're leaders. They win or lose, they do it together. They work together six days a week, if not seven during the season, and are playing in the offseason from seventh grade through ninth grade, through twelfth grade. These girls also run to help each other up, when one falls. And they also do that for the other team as well. They're tough, hardworking, focused, they don't make excuses, they make adjustments. They're leaders. They're caring to each other and to their opponents they play against. They do it as a Team. These are life skills. Life skills that all of us want our children to have, and they're doing this starting in seventh grade all the way up through twelfth grade. And this is under the leadership and direction of our Head Coach, and the Assistant Coaches and Staff. Because it is a school-based, not a recreational program, these girls must keep their grades up, must stay away from trouble and must go to school. All things that will help them be successful in the future because of Middle School sports and High School sports, these players get six years of program learning, belonging and giving. There are elementary students all over this town that look up to these kids and hope to be like them when they grow up. That's what a program is. And it's from seventh to twelfth grade. These are, this is a program that these girls will remember for the rest of their lives. So, tonight I just wanted to take a moment to thank our Middle School Coach, Coach Schendel who was here earlier, Freshman Coach, Coach Chup, JV Coach, Coach Warner, Head Coach, Coach Retzlaff, and our Volunteer Coach, Coach Catanho, and all of our Middle School, High School, and Volunteer Coaches for giving our kids and families so many great memories. Memories these kids will have the rest of their lives. Thank you, President Guas.

HEATHER GUAS: Well, that leads us to Board Member reports on Committees and/or information items.

2. Board members report on committees and/or information items.

Heather Guas remarked on being a sports Mom, and on the Board being open, transparent and show all the possible things that could be affected by the budget.

Wilbur Pan spoke about Girl's Basketball at Churchill and how it's important to remember that we're all on one team here and trying to solve the same problems. He spoke about continuing to contact our legislators because even if one commenting time is past, there are other bills working their way through. He spoke about Special Education funding. He also brought up the Resource Fair in Brunswick Square Mall coming up.

Heather Guas thanked the Administrative team and Karen Mandleur for all the work they are doing and encouraged everyone to check out the District Facebook posts.

In 2020, Governor Murphy signed the "Strengthening Gifted and Talented Education Act" into law.

The law states that districts need to make "adjustments or modifications to instruction enabling a student who is gifted and talented to participate in, benefit from, and demonstrate knowledge and application of the New Jersey Student Learning Standards in one or more content areas at the instructional level of the student, not just the student's grade level."



The law specifies the requirements districts must fulfill to provide gifted services.

The law <u>does not</u> specify:

- ✤ The curriculum to be used
- How services must be provided
- The purchase of testing materials



Colleagues in Other Districts

As we speak with other coordinators from across the state, we find very few commonalities.

Earlier this school year, for example, Dr. Moran attended a conference on gifted education in New Jersey. During one session, the moderator asked each of the thirty coordinators in the room to share how their districts were addressing the law.

Unsurprisingly, there were thirty different answers.



Multiple Measures

- We have been using local data to identify students' unique needs.
- With the recent availability of grant funds, we met with vendors and secured a contract for the *Naglieri* tests.
- This test has a non-verbal piece which will be beneficial for certain students with special needs and multilingual learners.






